

# 2010 Lightning Velo Membership Application

**Notice: This membership and release form is a contract with legal consequences.**

**Read it carefully before signing.**

In consideration of the acceptance of my membership, I hereby freely agree to and make the following contractual representations and agreements.

I fully realize the dangers of participating in bicycle riding and training and fully assume the risks associated with such participation including, by way of example, and not limitation, the following: the dangers of collision with pedestrians, vehicles, other riders, and fixed or moving objects; the dangers arising from surface hazards, equipment failure, inadequate safety equipment, and weather conditions; and the possibility of serious physical and/or mental trauma or injury associated with cycling and athletic competition.

I hereby waive, release and discharge for myself, my heirs, executors, administrators, legal representatives, assigns, and successors in interest (hereinafter collectively "successors") any and all rights and claims which I have or which may hereafter accrue to me against the officers and members of Lightning Velo for any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with the riding and training.

I agree it is my sole responsibility to be familiar with the ride course, Lightning Velo club rules, and all rules pertaining to riding on public roads. I understand and agree that situations may arise during the ride which may be beyond the immediate control of the club officials or organizers and I must continually ride so as to neither endanger myself nor others. I accept responsibility and liability for the condition and adequacy of my bike and equipment. I will ride wearing a helmet that satisfies the requirements of the current USA Cycling Racing Rules and Bylaws and that can protect against serious head injury. I assume all responsibility and liability for the selection of such a helmet. I have no physical or medical condition which, to my knowledge, would endanger myself or others if I participate in Lightning Velo activities, or would interfere with my ability to participate in such activities.

I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert my claim in contravention of this agreement, I or my successors shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally adjudged liable on such claim for willful and wanton negligence. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as a consent to any other provision herein or as a consent to any subsequent waiver or modification.
